

**Application Instructions  
And  
Hand Delivering Your Application**

To expedite matters and increase your chances of getting the property you should try to hand deliver the applications, **all supporting documents** (be sure to review the instructions on top of pg. 1 as to what we need), and a money order or a cashier's check. Cash is acceptable but it is at your risk. If lost, you will have no proof that it was given to us. **No personal checks** will be accepted. Remember, we need an application for anyone over 18 and the fee is \$30 **each**.

**Driving directions:** Take 15 Freeway and get off at the Rancho California Rd. exit. If you are coming **from** the north make a left on Rancho Calif. Rd.. If you are coming **from** the South make a right onto Rancho California Rd.. Make your 1st left on Ynez Rd. After that make your very 1st right into the shopping center. There is a sign that says Vons. Go up the driveway and the Postal Annex will be in front of you. Use the night slot in the door if it is after 6 PM during the week and after 3PM on Saturdays. They are closed on Sundays but you can still use the night slot.. Make sure CA-Realty #190 is on the envelope. The address of the Postal Annex is 27636 Ynez Rd. L-7, Temecula, CA, 92591.

The Postal Annex sells money orders if you need to buy one there. There is also a copying machine to make copies of your license, bank statements, pay stubs etc. Remember to include everything or we will be unable to thoroughly process your application. If you don't provide something you will need to explain why and it will cause delays.
