WESLEY his wife, the owners in fee simple of the tract of land shown hereon and more particularly described as follows: BEGINNING at the Northwest Corner of Section 19 T-3-S R-18-W and from thence run South 22°00' East thence East 22°00' to the East shore of Eastern Lake, thence along said West shore in a northerly direction to the point where the North boundary line of Section 19 intersects the said West shore, thence S 87°45' West 500 feet to North West Corner of said Section 19, the point of beginning, and here caused said land to be surveyed and platted as shown hereon, and do hereby dedicate to the perpetual use of the public as public highways the drives and avenues as shown hereon, reserving unto themselves, their heirs, successors assigns or legal representatives, the reversion or reversions of same whenever abandoned by the public or discontinued by law.

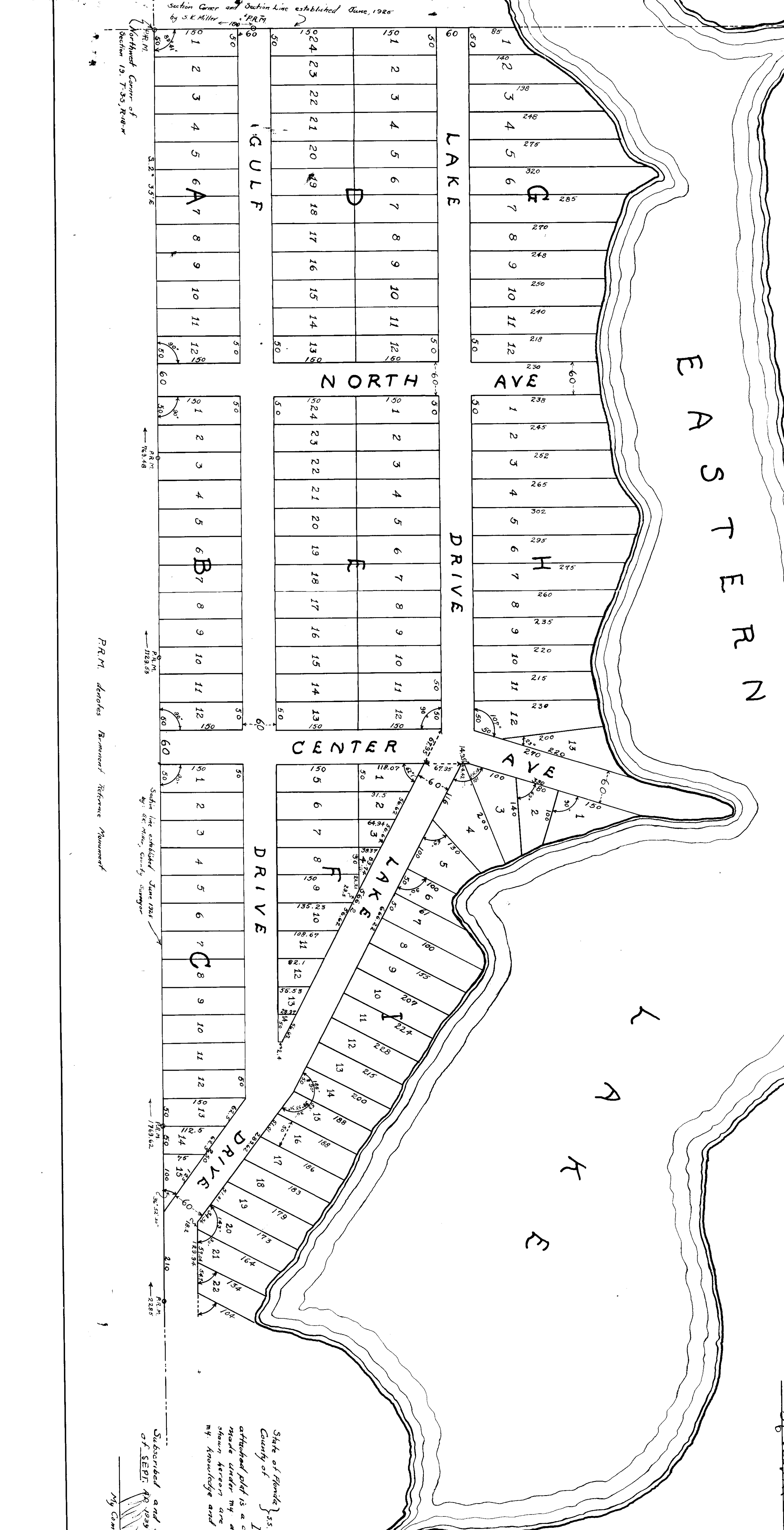
